### **Campaign Overview**

From 1<sup>st</sup> October the public will be able to show their vaccination status either through the NHS Scotland Covid Status app (launching 30<sup>th</sup> September) or by requesting a paper version via the NHS Helpline. Functionality within the Covid Status app will be updated in mid-October to include a QR with less personal information displayed. We will provide update stakeholder marketing materials where necessary at this point.

#### Key Messages

The campaign advises the public:

- From the 1<sup>st</sup> October they will need to prove they have been fully vaccinated to gain entry to late night venues with music, dancing and alcohol as well as most indoor and outdoor events
- > You can prove you have been fully vaccinated by showing your vaccination status by one of two ways;
  - Requesting your vaccination records via the NHS helpline
  - Downloading the NHS Scotland Covid Status App


